We're booked into the Club Floor at the historic Windsor Court Hotel. The Windsor Court is near, yet a comfortable distance from the French Quarter. The recent \$22 million restoration has brought real improvements without changing the Old World experience. We're in for a treat!

We plan to travel by coach in the same nice 36-seater that took us to Athens this past May. We considered the train from Birmingham; however, it's a 7-hour train ride plus the additional six hours driving to/from Birmingham. The coach is door-to-door; we'll be in New Orleans by cocktail hour.

**March 29, Sunday Columbus to New Orleans**

## **CONDITIONS**

**Reservations and Payment:** Reservations will be confirmed by American Travel Association (ATA) upon receipt of the Reservation Coupon and \$300 per person deposit. Receipt of final payment is due in the office of ATA no later than January 29, 2015. All payments must be made by check payable to American Travel Association or by MasterCard, Visa, Discover or American Express card.

**Cancellation:** Cancellations must be made in writing to ATA. To avoid discrepancies, ATA will not act on information given over the phone until written notice has been received.

**Land Package:** A \$200 per person cancellation fee will be charged regardless of the reason. Penalty on cancellations received between January 29<sup>th</sup> and departure will be a maximum of 100% of the land cost per person, depending upon the amount recoverable from the suppliers to whom payment had been sent. Cancellation penalties are required to offset non-refundable hotel and supplier payments made by ATA in advance of the tour. There will be no refund for unused services once the tour has begun.

**Insurance:** Trip cancellation, baggage and medical insurance coverage is available for purchase through a form to be sent by ATA. We strongly recommend insurance coverage. When last minute illnesses occur, the insurance helps offset non-refundable charges. You should check with your local insurance agent to see what is covered under your homeowner's policy.

**Prices:** This price is subject to change due to cost increases, and in number of participants upon which the tour cost is based (22). ATA reserves the right to increase the price for such reasons. All prices are based on rates and tariffs in effect on October 17, 2014.

**Health:** The Participant represents that neither he nor she nor anyone traveling with him or her has any physical or other condition or disability that could create a hazard to him-or-herself or other members of the tour. This program involves walking over uneven surfaces and climbing stairs at locations that are not handicap accessible. A letter of explanation of any physical or mental condition that may require medical attention or special equipment (wheelchair, for example) must be enclosed with the Reservation Form.
